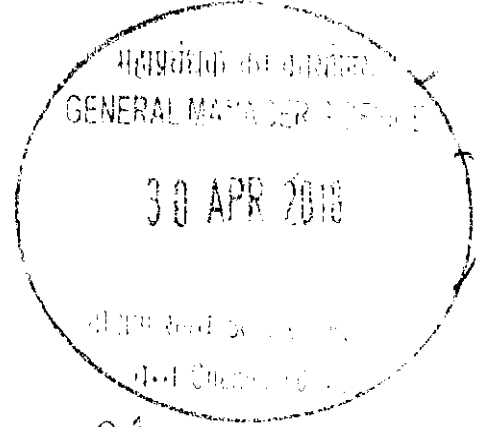

Please refer to SR's letter mentioned above seeking clarifications whether Dress Allowance is applicable to Prosecution Cadre of Indian Railways.

2. In this context, it is advised that Prosecution Cadre of Indian Railways have not been included in Board's letter No. PC-VII2017/1/7/5/7 (RBE No. 141/2017 dated 03.10.2017) as the modalities regarding formation of the cadre including RRs are yet to be finalised.


Public Prosecutors working in this Railway have sought payment of Dress Allowance in terms of Railway Board's letter cited under reference (3) above.

Their claim is that they were supplied uniform and paid Washing Allowance when the Public Prosecutors/Asst. Public Prosecutors were a part of the RPF cadre.

The Public Prosecutors/Asst. Public Prosecutors have been delinked from RPF cadre (vide references 1 & 2 cited above) and the constitution of a separate cadre of Public Prosecutors and Asst. Public Prosecutors is apparently under the consideration of the Board

In as much as the Public Prosecutors/Asst. Public Prosecutors are statutorily obliged to wear gowns and not as per Railway Uniform policy/rules (since they are now under the administrative control of AGM/ADRM as per reference 1 cited above), Board may kindly clarify whether Public Prosecutors/Asst. Public Prosecutors are covered by the instructions on Dress Allowance and, if so, the quantum thereof *per annum* may also kindly be specified
