

**Sub: Grant of Overtime Allowance (OTA) to Railway employees consequent upon revision of pay scales and allowances- date of effect.**

**Ref: Board's letter of even No. dated 28-11-2017 (RBE No. 175/2017)**

Pursuant to the recommendations of the Seventh Central Pay Commission, the rates of OTA have been revised w.e.f. 01-7-2017 vide Board's letter of even number dated 28-11-2017 (RBE No.175/2017). The issue of revising the date of effect of OTA w.e.f. 01-01-2016 had been under consideration and it has been decided that the basic pay and DA element for the purpose of OTA may be antedated to 01-01-2016 and other elements constituting emoluments for the purpose of OTA viz. HRA and Transport allowance etc. shall be taken into account at revised rates w e.f. 01-7-2017 as per the 7<sup>th</sup> CPC recommendations.
