Sub:- Additional relief on death/disability of Government Servants covered by the Defined Contribution Pension Scheme (NPS).

References is invited to Railways Board's letter No. 2016/AC-II/21/7 dated 27-11-17 (copy enclosed) wherein it has been highlighted that grant of pension/family pension to NPS beneficiaries has not commenced on some of the Zones/Units. Board has taken a serious note of the aforesaid delay.

2. As already brought out in the attached letter, instructions have been issued from time to time for making provisional pension payment to eligible NPS beneficiaries by the Railways and Joint Procedure Order has been put in place duly signed by the Personnel Department and the Accounts Department to ensure smooth disposal settlement of such cases. Relevant instructions have been reiterated vide Board's letter dated 02.01.17 (RBA No. 1/2017). A Compendium of circulars compiled by PFRDA has also been uploaded on the website of Indian Railways (RBA No. 162/2017).

3. It is accordingly desired that pension/family pension cases of NPS beneficiaries should be processed immediately without delay so that payment of pension in such cases commences at the earliest.



It has been again brought to the notice of Board's office that in some of the Zonal Railways, family pension to NPS beneficiaries has not yet commenced. This is a matter of grave concern.

In this regard, detailed instructions have been issued from time to time for making provisional pension payment to the eligible NPS beneficiaries by the Railways directly to the pensioner's account through ECS/RTGS etc. It is presumed that all the Railways and PUs have brought out a Joint Procedure Order in place duly signed by Personnel Department and Accounts Department to ensure smooth disposal of such settlement cases. These instructions were reiterated vide Board's letter dated 02.01.2017 (RBA No. 1/2017). A compendium of circulars compiled by PFRDA has also been uploaded in website of IR (RBA No. 162/2017).

Please connect Board's letter no. Board's letter dated 29.05.2009 (RBA No. 31/2009) 04.06.2010 (RBA No. 10/2010), 13.07.2010 (RBA No. 18/2010) and 04.10.2016 (RBA No 74/2016) wherein detailed instructions were issued for making provisional pension payment to the eligible NPS beneficiaries by the Railways directly to the pensioner's account through ECS, RTGS etc. It was also suggested to frame a JPO for the smooth disposal of such settlement cases.

During the recently held meeting with Federation, it has been informed that in some of the Zonal Railways, family pension to NPS beneficiaries has not yet commenced, which is a matter of serious concern. It is once again reiterated that the instructions issued by Railway Board needs to be complied with immediately.

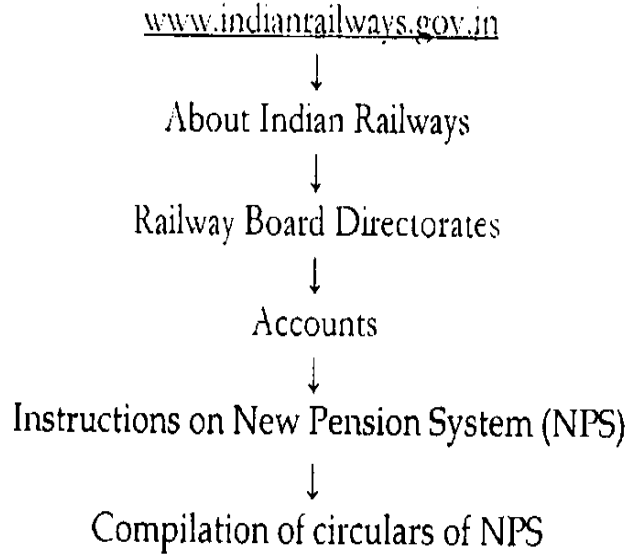


