Sub: Ad-hoc promotion to Senior Scale in Law Department.

Attention is invited to Board's letter of even number dt. 28.12.2018 (R.B.E. No 205/2018) wherein instructions were issued that Group 'B' officers of Law Department, when promoted to Senior Scale on ad-hoc basis, may be allowed to draw pay in Senior Scale [GP Rs.6600/- (pre-revised)/Level 11 as per 7th CPC], as may be admissible under the normal rules on completion of 6 years of regular service in Group 'B', as prescribed in the revised Recruitment Rules.

2 References in this regard have been received from few Railways seeking clarification regarding the date from which the benefits are to be accorded as per the above mentioned instructions. The matter has been examined in consultation with the Finance Directorate and it is advised that the benefit of pay in Senior Scale in accordance with the instructions dated 28.12.2018 may be given to only those officers who have been promoted against the vacancies occurring on and after the notification of Revised Recruitment Rules on 22.12.2017 and on fulfilling the conditions laid down, therein

Sub: Ad-hoc promotion to Senior Scale in Law Department.

In terms of Board's letters No. E(GP)81/1/91 dated 01.04.91 and No. E(GP)96/1/11 dated 03.09 1996, read with letter No. E(GP)99/1/33 dated 14.03.2012, Group 'B' Officers of Law Department, who have not put in 8 years of regular service in Group 'B', when detailed to look after duties in Senior Scale or are promoted on ad-hoc basis, are eligible to draw charge allowance of Rs. 1500/- p.m. subject to the condition that pay plus charge allowance should not exceed the pay that would have been admissible had the pay been fixed under Rule 1313 (FR 22) R-II on regular promotion. However, such officers are entitled to draw pay in Senior Scale, as may be admissible under the normal rules, only on completion of 8 years of regular service in Group 'B'.

2 As per the revised Recruitment Rules of Law Department (viz. Railways Deputy Chief Law Officer, Senior Law Officer and Law Officer (Group 'A' and Group 'B' posts) Recruitment Rules, 2017), notified vide Notification dated 22.12.2017, Group 'B' officers with 6 years of regular service in Group 'B' are eligible for consideration for regular promotion to Senior Scale. In view of the above, Group 'B' officers of Law Department, when promoted to Senior Scale on ad-hoc basis, may be allowed to draw pay in Senior Scale [GP Rs.6600/- (pre-revised)/Level 11 as per 7th CPC], as may be admissible under the normal rules on completion of 6 years of regular service in Group 'B', as prescribed in the revised Recruitment Rules.
