

Sub: Clarification on Model SOP item no 10 of Part 'F'

Ref: DGM/G, Central Railway letter no G.202/SOP-2017/Part F dated 30.01.2018

Vide reference above. Central Railway has sought clarification regarding power of inter-railway/inter-division transfer of non gazetted staff given to DRMs vide Model SOP of October 2017 Part F (Establishment Matters); Sub Part – II (non gazetted) item 10 (d).

2. It is clarified that the above mentioned power of inter-railway/inter-division transfer of non gazetted employees given to DRMs is to be exercised only for mutual transfer cases on the basis of own request of employees.
