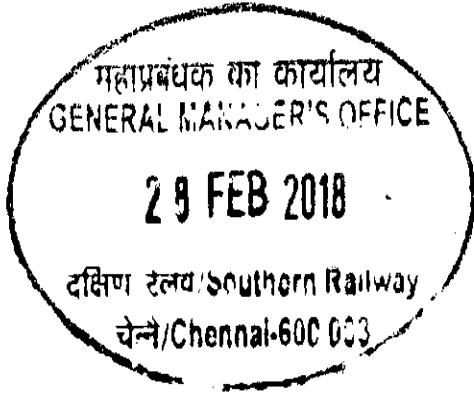




**Sub: Standardization on designations-Porter.**

**Ref: Monthly PCDOs.**

It has come to notice that some of the Railways have been reporting "Nil" figures in Pointsman Cadre due to continuation of old designation like Station Porter and Traffic Porter, leading to the inaccurate assignment of figures in the cadre of the Pointman. There are only two categories in Pointsman, v.i.z. Pointsman 'B' and Pointsman 'A' .

In regard to above it is advised that all Railways should discontinue the old designation like Station Porter, Platform Porter etc., where the work is primarily that of Pointsman. You are requested to send the confirmation of your Railway within 15 days of issue of this letter, failing which the consent of your Railway will be taken as granted.
