**OFFICE MEMORANDUM**

Subject: - Misuse of Identity Card by making its Duplicate –regarding . **12 SEP 2019**

The undersigned is directed to state that some persons are found using the scanned/duplicate (laminated) MHA Identity Card while entering into Government Buildings. Such cards have been confiscated by CISF/SSF personal manning the building gates from time to time. The use of such types of duplicate Identity Cards is an offence and is considered as a threat to the security. It is, therefore, impressed upon all concerned to discourage the use of such Identity Cards and initiate suitable disciplinary against those who are found involved in this act.

2. All the Ministries/Department of Government of India and all State Government Resident Commissioners are directed to bring the above information to the notice of all Identity Card bearers.
