NOTIFICATION

Sub:Selection for the post of Goods Guard in Level 5 in Pay Matrix against 15% LDCE Quota in Operating Department – reg.

It is proposed to conduct selection to the post of Goods Guard in Level 5 of VII th PC against 15% Limited Departmental Competitive Examination (15% LDCE Quota) in operating department. The applications are invited in the prescribed proforma from amongst Group C staff of operating and commercial departments of TPJ division.

I) Vacancies Assessed

The number of vacancies is indicated below

II) Eligibility Criteria:

Volunteers are called for from amongst serving regular non- Ministerial employees in Operating and Commercial Departments with a minimum of three years regular service in Operating and Commercial Departments, working in level-1 Pay Matrix to level-4 Pay Matrix (substantive)up to 40 years of age (45 years in case of SC /ST) as on date **12.10.2021** (the date of notification) with educational qualification of Graduation

Note: -

- (i) Upper age limit of 40 years for Genl/OBC and 45 years in case of SC/ST.
- (ii) Possessing the qualification graduation means that the graduation should have been obtained either under 11+1+3 years stream or under 10+2+3 years stream or 10+3+3 years stream from a recognized University.

(or)

As clarified by Railway Board vide letter No. E(NG)I-2014/PM1/1-CC dated 22.05.2014 and E(NG)II/2013/RR-1/8 dated 18.03.2015 on the aspect of recognition of degree obtained from Open University without prosecuting 10+2 or 11+1 stream of studies as under: -

"No student is eligible for admission of the 1st Degree course through non-formal / distance education unless he has successfully completed 12 years schooling through an examination conducted by a Board / University". In case there is no previous academic record, he/she is eligible for admission if he/she has passed an entrance test conducted by the University provided that he/she is not below the age of 18 years on July 1 of the year of admission". However, in such cases the proof of passing the entrance test conducted by the University should be enclosed.

Post Graduate obtained directly from Open University or other such institutions will not be eligible and such applications will summarily be rejected.

(iii) Self attested copies of all the certificates i.e., 10th/11th, 12th/PUC/Pre-Degree/ Entrance Test/ Graduation in proof of the qualification and community Certificate i.e., SC/ST should be enclosed, without which the application will be summarily rejected.

III. Syllabus: -

The Syllabus for the written examination is enclosed as **Annexure 'A'** and duration of examination will be 120 Minutes.

IV) Pre-promotion Traning

In terms of instructions contained in Railway Board's Lr. NO.88-E(SCT)I/42/2 dated 11.04.1991, the pre-promotional training for eligible "ST" volunteers is to be conducted covering the syllabus of the examination for selection to the safety category posts and will be imparted for a period of 03 to 04 weeks. In case if any employee expresses his/ her unwillingness for pre-promotion training, a written declaration to the effect may be forwarded to this office.

V) Criteria for the selection

The volunteers who have passed the written examination have to undergo Medical Examination for "AYE TWO" medical classification and those found fit in "AYE TWO" medical classification will only be considered for empanelment to the extent of vacancies. Employees placed in the panel will be sent for initial training course for Guards at MDZTI/TPJ. Those who successfully complete the initial training will be promoted as Goods Guard in level-5 in pay Matrix against the earmarked quota as and when vacancies occur and those who fail in the training will be sent back to their parent cadre.

Candidate must obtain minimum 60 marks in professional ability and 60 marks in aggregate . Being a safety category , no relaxation of marks will be allowed in respect of SC/ST employees .As the filling up of posts involves calling of volunteers from different categories the panel will be formed in the order of merit as per the instructions in Railway Board's letter no. E(NG)/I/2008/PM7/4/SLP Dated 19.06.2009 (RBE No.113/2009 – PBC No: 121/2009)

The promotion as Goods Guard will be provisional subject to outcome of the Court Cases pending.

VI) Mode of Examination:

The question paper will be supplied in tri- language viz English, Hindi, Tamil based on employees request in the application. Employees should exercise their option of language clearly in the Application form and write the answers in respective language opted by them.

The selection consists of written test as per Board's letter no E(NG)1/2018PM1/4 dated.14.12.2018(RBE No.196/2018). The question paper will be 100% objective type multiple choice question for the written examination and 10% of the total marks will be from Official Language Policy and rules. The questions on Official Language policy and the rules may not, however, be compulsory.

The examination may be conducted in CBE mode or pen and paper test .There shall be negative marking for incorrect answer .One third of the marks allotted for each question will be deducted for wrong answers.

There will be no supplementary examination to the absentees in the main examination, since selection is for calling volunteers. Employees once selected for the post and undergone training will not be permitted to withdraw their candidature and not allowed to go back to their parent cadre under any circumstances.

Wide publicity of this notification should be given to all eligible staff including those who are on deputation ,leave /Sick etc., Representation /application received beyond the last date of receipt of application , should not be entertained and the same should be disposed off at the unit level rejecting them on account of late receipt.

The Pre-Promotional training for the eligible "ST" volunteers will be advised separately

The staff selected and promoted as Goods Guard will have to seek further promotions as per Avenue prescribed to Goods Guard and no requests for repatriation to their parent category will be entertained under any circumstances.

VII). Submission of Applications

The supervisory officials may notify the contents of this notification to the employees under their control and forward the applications from the eligible willing employees in the enclosed proforma in Annexure "A" in one bunch in a sealed cover addressed to APO/T/TPJ and to reach this office on or before 08.11.2021. A "NIL" statement may be sent to this office if "NO" volunteers from your units

The application filled in all respect in the prescribed proforma in Annexure 'B' from the eligible volunteers should be submitted through supervisor concerned. The application should contain the name, designation, station stamp & date of the supervisory official, who is forwarding the application.

No applications should be sent through the employees in a piece meal manner. Application received after the due date will not be entertained.
