The Selection is subject to the retired employees being found suitable by the Committee constituted for the purpose.					
	b) Re-engaged retired employee will be discharged immediately, on joining the selected candidate from RRB/RRC or regular employees on transfer/ Promotion.					
	c) The Administration is at liberty to terminate the service of the reengaged personnel after giving a notice period of one month, in case their performance is found to be unsatisfactory. The service of the reengaged personnel will be terminated on attaining the age of 65 years or on joining the selected candidate from RRB/RRC or posting of regular employees on transfer/promotion or on whichever is earlier. The re-engaged employees will not have the right for continuity in service.
