Further to this office notification cited under reference, 43 employees who have volunteered for the selection to the post of JE/DSL (Mech) in Diesel Shed/GOC in Mechanical Department in Level – 6 against 25% LDCE Quota, only 41 employees are fulfilling the terms and conditions stipulated vide this office letter cited above and found eligible. The list of eligible employees are enclosed in **Annexure – A**. Two employees are found ineligible since they do not possess required educational qualification for the above post and listed in **Annexure – B**.

The eligible employees as per **Annexure – A** may be alerted to be in readiness to appear for the CCBT which will be held shortly. The date/venue of examination will be announced in due course.

While relieving the employee to attend the examination, the relieving letter should have the photograph of the employee affixed on it duly attested in the manner, viz., the rubber stamp should clearly indicate the name and designation of the Supervisory officials and also have the specimen signature of the employee.

Employees who qualify in the CCBT will be sent for medical examination for “**AYE THREE**” before directing them for training.

As already advised in the notification, there will be **NO SUPPLEMENTARY EXAMINATION** for the employees those who are not attending the examination.
