- 3 They will take their Seniority unit to which they are transferred as per extant orders applicable for such one way transfer on bottom seniority from time to time.
- 4 There is no DAR/SPE/Vigilance cases against them
- 5 The Date of Joining of the Employees should be advised to all concerned
- 6 They should report directly to CWM/S&T WS/O/PTJ for further orders.
- 7 The Employees should declare for accepting the above conditions applicable for one way transfer to S&T WS/PTJ at the time of reporting.
- 8 The relieving order from DPO/WPO concerned should have the Photograph, Signature and left Thumb Impression of the employee duly attested i.e. Official seal should clearly indicate the Name and Designation of the Controlling authority 1-2001/TR-16 dated 21.11.2001 (RBE No.229/2001) forwarded by CPO/MAS vide letter No.(R)MC/24/Transfer dated 14.12.2001
- 9 If any of the Employees ordered for one way transfer to S&T WS/PTJ in this Office Order are unwilling to carryout their one way transfer the same has to be intimated to this office immediately in writing thro' proper channel.
- 10 The above said Employees who are under orders of transfer to S & T /Workshop/PTJ should be relieved to this unit within one month. Otherwise it will be deemed that they are unwilling to carry out their request transfer under IDT and necessary orders will be issued for cancelling their request order under IDT.
- 11 All Employees Joining this unit on Bottom Seniority as Helpers will be intially posted to S&T Workshop Canteen and Will be posted to S&T Workshop as per their Seniority.
