It is proposed to conduct a selection in the category of Shunting Master Grade II in Level -4 to fill up 14 vacancies (UR-9, SC-4, ST-1). The selection is on Divisional basis and the employees in the event of being selected should be prepared to join any station to which they may be posted within the division and if they do not agree to this, they need not appear for the selection. The selection consists of written test and perusal of records.

If any of the employees are not willing to appear for the written test, the same should be advised to this office on or before 04.03.21 duly sending the letter of unwillingness. If any of the employees are expressed unwillingness, the next eligible employee shown in the 'Stand by' list as per seniority will be included in the main list and alerted for the above selection. Further they may be advised to express their willingness to write the examination whether in Hindi (or) English (or) Tamil and for the same the specimen is enclosed as ANNEXURE – A. Those who are giving option to write the examination in Tamil, separate eligiblty test in English will be conducted for them in the afternoon of the same day of written examination or after the main examination. The employees who are willing to attend the written test shall not be allowed to go on leave except in urgent cases. Even in such cases, it is the responsibility of the supervisory officials concerned to notify about the date of written examination and relieve them in time to attend the written examination without fail. The employees will be permitted to appear for the supplementary selection only for the following reasons (viz):-

- 1) Those who could not be relived due to administrative reasons.
- 2) Any other reasons over which the employee has no control.

Employees concerned may be notified of the selection under clear acknowledgement. Supervisory officials to notify the employees concerned who have been transferred to any other station / under sick list.
