II. The senior most employee Shri.K.VIJI, TM 4244, Tech I/DSL/E/GOC is not considered for promotion, since he is not having the prescribed benchmark for promotion. Sri V.Vijayakumar, TM 3840, Tech.I/E/DSL/GOC is under deputation at IRCON/Sri Lanka will be considered for promotion on repatriation to this division.

Note The above promotion is ordered to take with immediate effect subject to the following conditions:

- 1 He is free from DAR/SPE/Vig. Cases pending/contemplated against him and not undergoing any penalty on the date of promotion. The supervisory official should ensure this aspect. In case on the date of giving independent duty, the employee is undergoing any penalty or DAR action initiated against him is pending, he should not be given independent duty.
- 2 The employee is eligible for Fixation of Pay on promotion, if found eligible. In case where financial up-gradation has already been granted under MACP Scheme, there is no further fixation of pay will arise at the time of regular promotion.
- 3 He is allowed to exercise option within a period of one month from the date of shouldering higher responsibility under Rule 1313 (FR 22 (i) (a)(i) of R.II). In case the employee do not exercise any option within the stipulated period, it may be noted that his pay will be fixed as envisaged under Rule 1313 (FR 22 of R.II) and no further option (revision) is permissible. - 4 The above promotion is subject to the outcome of pending litigations/court case.

The date of shouldering higher responsibility should be advised to this Office immediately.
