Wing / GOC** in Level 2 in VII PC (GP 1900 in VI PC) of Mechl. Dept., in group 'C' services as skilled artisan is now appointed as Trainee Tech.Gr.III/Mech/DSL/GOC in Level 2 in VII PC (GP 1900 in VI PC) on a monthly stipend of Rs.19900/- per month plus allowances admissible under the rules in force from time to time and directed to undergo training for a period of 6(Six) months at SSE/Mech/DSL Shed/GOC.

Note:

His appointment is subject to the following terms and conditions:

- 1 The appointment will be temporary for the first 2 yrs., and which will be deemed to be on probation after training.
- 2 It should be clearly be understood that his employment under Government is temporary and that his services may be terminated at any time without notice of such termination is due to expiry of the officiating vacancy in which he may be appointed or due to his mental or physical incapacity or due to his removal or dismissal as a disciplinary measure after compliance with the provisions of clause (2) of Article 311 of the constitution of India. Otherwise his services will be terminated at any time on 14 days notice given by either side without any reasons being assigned. The appointing authority however reserves the right of terminating his services forthwith, before the expiry of the stipulated period of notice by making payment to him. The amount equivalent to the pay and allowance for the period of notice or the unexpired portion thereof. He should resign or quit his employment except with the previous consent in writing of the head of the department or office in which he is promoted thereof.
- 3 He should not resign or quit his employment except with the previous consent in writing of the head of the department or office in which he is employed.


- 4 He will be governed by the newly introduced Restructured Defined Contribution Pension System applicable to all new entrants to Central Government Service including Railway Service with effect from 01.01.2004 in terms of Railway Board's Ir.No.E(III) 2003/PN/1/24 (RBE No.225/04) dtd:31.12.2003 and No.2004/AC-III/21-1 dtd:01.02.2004 (circulated under PBC No.36/2004). The existing Railway Service (Pension) Rules 1993 including commutation of pension rules and Extraordinary pension Rules and State Railway Provident Fund Rules as contained on Indian Railway Established Code Vol.I (1965 Edition) 1995 reprint shall not be applicable to the above named newly recruited / appointed candidates. For the purpose of leave, he will be governed by the leave rules as admissible and as corrected from time to time.
- 5 He will be held responsible for the case of Government Money, Goods and Stores and any other property that may be entrusted to them in the discharge of his official duties.
- 6 His continuing in service is subject to (A) Qualifying the duties prescribed for the post they held. (B) Fulfilling such other General condition of service as may be laid down from time to time. (C) Being prepared to serve any where on the Southern Railway system and (D) Compliance to all Rules and Regulations applicable to the appointment.
- 7 In all matters not specifically provided for here in rule, he will be governed by the provisions of Indian Railway Code Manuals and other extant orders as amended or issued from time to time.
- 8 His appointment is provisional subject to the receipt of verification report from Civil/Police authorities regarding their character and antecedents. If anything adverse in the said report is found regarding their suitability for appointment, please note that he is liable to be terminated.
- 9 On completion of training he may be trade tested for the post of Tech.Gr.III in Level 02 in VII PC and his absorption in regular cadre will be subject to passing the Trade Test.
