

The above promotion is ordered to take with immediate effect subject to the following conditions:

- 1 They are free from DAR/SPE/Vig. Cases pending/contemplated against them and not undergoing any penalty on the date of promotion. The supervisory official should ensure this aspect. In case on the date of giving independent duty, the employee is undergoing any penalty or DAR action initiated against him is pending, he should not be given independent duty.
- 2 They will be eligible for Fixation of Pay on promotion, if found eligible. In case where financial up-gradation has already been granted under MACP Scheme, there is no further fixation of pay will arise at the time of regular promotion. The date of shouldering higher responsibility should be advised to this Office immediately.
- 3 They are allowed to exercise option within a period of one month from the date of shouldering higher responsibility under Rule 1313 (FR 22 (i) (a) (i) of R.II). In case the employees do not exercise any option within the stipulated period, it may be noted that their pay will be fixed as envisaged under Rule 1313 (FR 22 of R.II) and no further option (revision) is permissible. - 4 The above promotion is subject to the outcome of pending litigations/court case.
