3. As the transfer is ordered at his own request he is not eligible for transfer grant, joining time etc., on transfer account.
4. He will not seek re-transfer to his parent unit / Railway/Division at a later date.
5. A declaration accepting the above condition should be obtained from the employee before he is relieved on transfer and a copy there of be sent to this office for record.
6. The relieving memorandum / order sparing the employee should have the photograph of the employee pasted on it duly attested in the manner viz., the rubber stamp should clearly Indicate the name and designation of the Supervisor / Officer. The memorandum / order should also have the signature of the transferred employee and his left thumb impression both of which should be duly attested by the Officer signing the memorandum / order with his name and designation appearing below the signature as stipulated in Rly. Bd's Ir.No.E(NG) 1-2001/TR-16 dtd:21.11.2001.

He may be relieved immediately to this office for further direction to DRM/P/Ratlam division/Western Railway.
