**Sri A.P.Asaithambi** Ex employee PF No.15200037916, TWD/OHE/TBM, retired on 30.11.2016 MAS Dn, and now found fit in AYE ONE With Glasses in Medical Classification, has fulfilled the eligibility conditions and has accepted to be re-engaged on the terms and conditions specified is reengaged as Tower Wagon Driver in Electrical Department . He is re-engaged and directed to work under the control of General Manager/Electrrical RVNL Mylopore Chennai.

The above re-engagement is made on the following conditions.

- 1] Retired employee is re-engaged upto 65 years of age and or 01.12.2020 whichever is earlier. Those re-engaged shall continue upto the last day of the month in which he attains the age of 65 years ie following the same system as that of normal retirement or upto 01.12.2020.
- 2] Retired employee is re-engaged on monthly remuneration which is determined by reducing pension from his last pay drawn, ie Basic Pay+DA. Pension Payment Order and Bank account Pass Book is to be obtained for determining the same. The Remuneration is to be claimed by RVNL.
- 3] Retired employee should not have been covered under safety Related Retirement Scheme [SRRS]/ Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff [LARSGESS]. Retired Employee should not have been compulsorily retired or removed or dismissed from services.
- 4] The Administration is at liberty to terminate the services of the re-engaged personnel without prior notice in case their performance is found to be unsatisfactory. The Service of the re-engaged personnel will be terminated /discharged on attaining the age of 65 years or on joining the selected candidate from RRB/RRC or posting of regular employee on transfer/promotion or on 01.12.2020 whichever earlier. The re-engaged employee will not have the right for continuity in service. The re-engagement is subject to condition laid down in Railway Board's Ir. No.E(NG)-II /2007/RC-4/CORE/1dated 16.10.2017 (RBENo150/2017) PBC 192/2017 and (2) nOE(NG)-II/2007/RC-4/CORE/1 dated 12.12.2017(RBE nO193/2017) and such other rules in force from time to time.
