NOTE: The appointment is subject to the following Terms and Conditions.

1) Their appointment will be temporary for the first two years, which will be on probation after training. It must clearly be understood that their employment under GOVERNMENT is temporary and their services may be terminated at any time without notice if such termination is due to the expiry of the officiating vacancy in which they may be appointed or due to their mental or physical incapacity or due to their removal or dismissal as a disciplinary measure after compliance with the provision of Clause (2) of Article 311 of the constitution of India. Otherwise their services will be terminated any time on 14 days notice given by without any reasons being assigned. The appointing authority however reserves the right of terminating his services forthwith, before the expiry of the stipulated period of notice by making payment to the amount equivalent to the pay and allowance for the period of notice or the un expired portion thereof. They should not resign or quit their employment except with the previous consent in writing of the head of the Department or Office in which they are employed.

2) They will be governed by the newly introduced RESTRUCTURED DEFINED CONTRIBUTION PENSION SYSTEM applicable to all new entrants of CENTRAL GOVERNMENT SERVICE including RAILWAY SERVICE with effect from 01.01.2004 in terms of Railway Board's letter No.E III 2003/PNI/24 (RBE No.225/04 dated 31.12.2003 and No. 2004 / AC-III/21-1 dated 01.02.2004 (Circulated under PBC No.36 / 2004). The Railway Service (Pension) Rules 1993 including commutation of pension Rules and Extraordinary pension rules and State Railway Provident Fund Rules as contained in Indian Railway Established Code Vol.I (1965 Edition) 1995 reprint shall not be applicable to the above named newly recruited/appointed candidates. For the purpose of leave, they will be governed by the leave Rules as admissible and as corrected from time to time.

3) They will be held responsible for the care of Government Money, Goods and Stores and any other property that may be entrusted to their care in the discharge of their official duties.

4) They will be liable to Military services in Railway Engineering Units or the Territorial Army for a period of 2 years in the Territorial Army service as may be amended for such periods from time to time.

5) The Officers / servicemen exercising option in accordance with the provisions for counting of Military Service as qualifying service shall be required to refund the benefits in accordance with the provisions of the Rule 34(1) of Railway services (Pension) Rules – 1993 along



with interest laid down in Para 3 of Board's letter No.F (E) III/ 94/PNI/28 dated 01.11.1994, option should be exercised within a period of 6 months from the date of appointment.

6) The seniority of the above candidates will be assigned based on the panel seniority of RRC on publication.

Their continuing services are subject to:

- A) Qualifying the duties prescribed for the post they held.
- B) Fulfilling such other General Condition of service as may be laid down from time to time.
- C) Being prepared to serve anywhere on the Southern Railway System and
- D) Compliance to all Rules and Regulations applicable to his appointment.

In all matters not specifically provided for here in rule, they will be governed by the provisions of Indian Railway Codes, Manuals and other extant orders as amended or issued from time to time.
