The re-allotment is ordered subject to the following conditions:

1. There should be no DAR/SPE/Vig cases pending against them on the date of relief.
2. They should handover all Railway materials if any in their possession to the Supervisory official concerned before being relieved.
3. The re-allotment is ordered at their own request and hence they are not entitled for any privileges like joining time, etc.
4. They should vacate the Railway quarters, if occupied, immediately as per extant rules.
5. They should abide by all the rules and regulations governing such re-allotment.
6. a) The re-allotment is made only to the particular Division. Allotment of these Substitues within the Division may be done at the Divisional level in terms of Para - 231 of IREC - Vol.I and RBE.No.120/2018.
b) They should be prepared to serve anywhere in the respective Division.
7. The request of the Substitues for re-allotment to Workshops has not been agreed to. Instead, they are considered for re-allotment to the adjoining Divisions.
8. The Substitues mentioned above should join the new place of posting immediately.
9. The relieving order should have the photograph, Signature and LTI of the employee duly attested by the controlling officer/supervisor as stipulated in RB's Lr.No./E(NG)1/2001/TR-16, dated 21.11.2001(RBE No.229/2001).
10. The date of relief/joining in the new unit may be advised to all concerned quoting reference to this office order.
11. They may be relieved immediately with instructions to report to Sr.DPO/TPJ with 2 recent passport size photos and leave/Pass availed particulars. They will be further relieved from Divisional office to report to concerned Division.
