Competent Authority has accorded approval for the Inter-Railway One Way Request Transfer of **Shri. Sunil Kumar Rajak**, Junior Engineer/P.Way/CDM of Engineering Department of TPJ Division /Southern Railway to Malda Division /Eastern Railway in Pay Matrix Level 6 in VII PC (in PB 2 -Rs.9300-34800 with Grade Pay Rs.4200/- in VI PC) on bottom seniority subject to usual terms and conditions applicable to such transfer.

The above Inter-Railway One Way Request Transfer is ordered subject to the usual terms and conditions as detailed below.

- a) He is not eligible for any privileges on transfer account such as like transfer grant , joining time,CTG etc., on transfer account as the transfer is ordered on request grounds.
- b) He should not seek re-transfer to his parent division at a later date.
- c) He will retain his lien in the Parent Division till he is permanently absorbed in the new seniority unit.
- d) The date of relieving/joining in the new unit should be advised to all concerned quoting reference to this office order.
- e) He should handover all Railway Materials if any in his possession to the Supervisory official concerned before being relieved to Eastern railway.
- f) He should be no DAR/SPE /Vig cases pending against him on the date of relief.
- g) He should abide by all the rules and regulations governing one way request transfer.
- h) He should be prepared to serve anywhere in the respective Division/Railway.
- i) Railway Quarters in occupation if any is to be vacated immediately on his relief.
- j) The relieving order should have the Photograph, Signature and LTI of the employee duly attested by the controlling Officer/Supervisor as stipulated in RB's Lr.NO. E/NG 1/2001/TR-16, dated 21.11.2001(RBE No. 229/2001)
- k) He may be relieved immediately to carry out the IRT with instructions to report to Sr.,DPO/TPJ with two recent passport size photographs and leave /Pass availed particulars. He will be further relieved from Divisional Office to report to concerned Divisions/railways.

- 1) The above one way request transfer on IRT is subject to the condition that he will be absorbed as JE/P.Way in Pay Matrix level 6 in VII PC (GP Rs. 4200/-in VI PC) irrespective of his present grade and also in bottom seniority in the absorbing unit.
