**MEMORANDUM**

Sub: Grant of notional increment on 1<sup>st</sup> July/1<sup>st</sup> January to the employees who retired from Central Govt. service on 30<sup>th</sup> June/31<sup>st</sup> December respectively for the purpose of calculating their pensionary benefits – reg.

Ref: Rly.Bd letter No PC-VI/2020/CC/13 dt. 03.12.2024 issued under PBC 39/2025 dt: 05.02.2025.

With reference to the Railway Board letter cited under reference and In terms of Para 7 of DoPT Memorandum No. PC-VI/2020/CC/13 dated: 03.12.2024, it is advised that in pursuance of the Order dated: 06.09.24 of the Hon'ble Supreme Court, action is to be taken to allow the increment on 1<sup>st</sup> July/1<sup>st</sup> January to the Central Government employees who retired/are retiring a day before it became due i.e., on 30<sup>th</sup> June/31<sup>st</sup> December and have rendered the requisite qualifying service as on the date of their Superannuation with satisfactory work and good conduct for calculating the pension admissible to them.

Accordingly, the under mentioned employees are found eligible for the grant of Notional increment from the date following the date of their retirement are granted one increment notionally only for the purpose of calculation of Pensionary benefits.
