The appointment is subject to the following Terms and Conditions:

1. The above employee will be on probation for a period of two years from the date of appointment.
2. The service is temporary and is liable for termination on 14 days notice on either side except that no such notice is required, if the termination of service is due to the expiry of sanction to the post she hold or on return to duty of the absentee in whose place she may be engaged in which case her services will be automatically terminated from the date of expiry of the sanction or from the date the former resumes duty as the case may be. Also no such notice will be required if the termination of service is due to her mental or physical incapacity or to her removal or dismissal as a disciplinary measure after compliance with provisions of clause 2 of Article 311 of the Constitution of India. The appointing authority reserves the right to terminate the services forthwith or before the expiry of the stipulated period of notice by making payments, an amount equivalent to the pay and the allowances for the period of notice or the unexpired porting thereof.
3. She will conform and comply to all the Rules and Regulations applicable to the appointment as laid down in the offer of appointment and to such Rules in force from time to time.
4. Her continuance in the grade is subject to qualifying in the duties prescribed for the posts she holds and fulfilling such other general conditions of service as may be laid down from time to time. She should be prepared to serve anywhere on the Southern Railway.
5. She will be held responsible for the charge and care of Government money, goods and stores and

all other property that may be entrusted to her.

6. She is required to serve in field allied or different from the one she is appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be altered covering different skills and fields in which she should be ready to serve. Refusal to perform duty in this manner will make her liable for termination of service.

7. The appointment is provisional subject to the outcome of verification of Character and Antecedents which will be verified through proper channel.

8. The appointment is provisional and is subject to the Scheduled Caste/Scheduled Tribe/Other Backward Community certificates being verified through proper channel and if the verification reveals that the claim belong to Scheduled Caste/Scheduled Tribe/Other Backward Community, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificate(s).

9. She is covered under the newly introduced restructured defined contribution pension system(RBE No.225/2003).Newly recruited person, who joins service on or after 1st April 2025 may exercise option to be covered under Unified Pension Scheme (UPS) within thirty days from the date of joining Central Government services or within such extended timelines, if any, allowed by the Central Government. The option once exercised shall be final and irrevocable and new recruited person, who does not exercise the Unified Pension Scheme (UPS) option under National Pension Scheme(NPS) within the timelines laid down, shall be deemed to have opted to continue without UPS option.

10. In all other matters not specifically provided hereon or on the Recruitment Rules, She will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.

Note:- (a) Oath of Allegiance to the Union of India has been administered to her.

(b) The seniority will be assigned as per extant provision.

(c) The Salary will be made through Bank only. In this connection she will have to provide Savings Bank account number, Bank details and Permanent Account Number (PAN) for this purpose.
