1. They should vacate Railway Quarters, if any occupation as per extant rules under advice to this office. If they fail to vacate their quarters within the permissible period for which retention is permitted, the following course of action will be taken.

a) Cancellation of allotment.

b) Eviction proceedings.

c) Withholding of post retirement pass at the rate of one set per month of unauthorized occupation. For this purpose, more than 10 days will be taken as a full month and withholding of payment of DCRG. They should be stopped from duty on the A.N of the date of retirement mentioned above without fail. They should not be allowed to continue beyond the date of retirement under any circumstances. Date of termination should be advised to this office promptly.
