1. They should handover all the railway materials including the Medical Identity Card to the Supervisory Officials concerned.
2. Railway Quarters if any occupation should be vacated within the permissible period, failure of which the following course of action will be taken.
 - a) Cancellation of allotment of quarters.
 - b) Eviction proceedings.
 - c) Recovery of damage rate of rent as per rules in force.
 - d) Withholding of DCRG in full.
 - e) Withholding of Post Retirement Pass at the rate of one set per month for unauthorized occupation and for the purpose, 10 days or more will be taken as full month.
 - f) Unless or otherwise, the employee in occupation of quarters apply for retention of quarters on or before the date of retirement, the occupation of quarters will be treated as unauthorised beyond the date of superannuation.
 - g) The supervisory officials have to ensure that no name of the staff working under their control is left out from the list during the above period. If there is any omission/correction the same is to advised to this office immediately.
