- The employees who have been granted financial up gradation under MACP Scheme in Level-7 (Pre-Revised as per VI PC Grade Pay Rs.4600/-) are not entitled for fixation of pay on promotion as per extant rules.

- (iv) Promotees on expressing their unwillingness for promotion will be debarred for further promotion for a period of one year from the date of issue of this office order and they will rank junior to all the employees who are to be in terms of Para 224 of IREM 1989 Vol.I.
- (v) The above promotional order is provisional subject to the final outcome of pending litigations / Court cases on the subject.
- (vi) They are allowed to exercise their option within a period of one month from the date of shouldering higher responsibility under rule 1313 (FR 22 of (i)(a)(i) of RII). In case the employees do not exercise any option, within the stipulated period, it may be noted that their pay will be fixed as envisaged under 1313 (FR 22 of R.II) and no further option (Revision) is permissible (PBC 115/2017).
- (vii) Railway Quarters if any in occupation should be vacated as per extant orders.
