The above Inter-Divisional transfer is ordered subject to the following conditions:

1. At the time of relieving, the above employees who are now working as TM-II and TM-III in Level 4 and Level 3 of Pay Matrix respectively may be reverted as TM-IV in Level 1 of Pay Matrix to carry out the IRT. Necessary reversion entry may be made in their Service Register.
2. They should not seek re-transfer to their parent division at a later date.
3. They will retain their lien in the parent Division till they are permanently absorbed in the new seniority unit.
4. As the transfer is ordered at their own request, they are not entitled for any privileges like transfer grant, joining time, CTG etc., on transfer account.
5. They should handover all Railway materials if any in their possession to the Supervisory official concerned before being relieved to other Railway.
6. There should be no DAR/SPE/Vig cases pending against them on the date of relief.
7. They should abide by all the rules and regulations governing one way request transfer.
8. They should be prepared to serve anywhere in the respective Division/ Railway.
9. Railway Quarters in occupation if any is to be vacated immediately on their relief.
10. The date of relief/joining in the new unit may be advised to all concerned quoting reference to this office order.
11. The relieving order should have the photograph, Signature and LTI of the employee duly attested by the controlling officer/supervisor as stipulated in RB's Lr.No./E(NG)1/2001/TR-16, dated 21.11.2001(RBE No.229/2001).
12. They may be relieved immediately to carry out the IRT with instructions to report to Sr.DPO/TPJ with 2 recent passport size photos and leave/Pass availed particulars. They will be further relieved from Divisional office to report to concerned Divisions/ Railways.
13. The above one way request transfer on IRT is subject to the condition that they will be absorbed as T.M-IV in Pay Matrix level 1 in VII PC[GP Rs.1800/- in VI PC] irrespective of their present grade and also in bottom seniority in the absorbing unit.
