The above re-engagement is made on the following conditions:

- 1) Retired employees are re-engaged up to 65 years of age or 01.12.2020 whichever is earlier.
- 2) Retired employees are re-engaged on monthly remuneration which is determined by reducing pension from his last pay drawn, i.e., **Basic Pay**. Pension Payment Order and Bank account Pass Book is to be obtained for determining the same.
- 3) Retired employees should not have been covered under safety Related Retirement Scheme (SRRS)/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS). Retired employees should not have been compulsorily retired or removed or dismissed from services.

- 4) The Administration is at liberty to terminate the services of the re-engaged personnel without prior notice in case their performance is found to be unsatisfactory. The service of the re-engaged personnel will be terminated / discharged on attaining the age of 65 years or on joining the selected candidates from RRB/RRC or posting of regular employees on transfer/Promotion or on 01.12.2020 whichever is earlier. The re-engaged employees will not have the right for continuity in service. The re-engagement is subject to conditions laid down in Railway Board's letters (1) No.E(NG)-II/2007/RC-4/CORE/1 dated 16.10.2017 (RBE No.150/2017) – PBC No.192/2017 and (2) No.E(NG)-II/2007/RC-4/CORE/1 dated 12.12.2017 & 28.11.19 (RBE No.193/2017) &(RBE No. 207/2019) and such other rules in force from time to time.
- 5) The Services rendered during the period of re-engagement will not be taken into account for any purpose.
- 6) The re-engaged are to comply all safety norms provided for their personal safety and the safety of others/ Public.
