It is proposed to fill up the vacancies of JE/Works in Level-6 of the pay matrix in VII PC against 15% Intermediate Apprenticeship Quota by selection. The vacancies assessed for the above selection is as under:

**UR-2**

The selection will consist of written test and scrutiny of records of service.

The employees working on regular measure in skilled grade in works branch with the following conditions are eligible to apply as per (RBE 93/2022):

1. The upper age limit should not exceed 45 years.
2. Staff in skilled grades in Works Branch having the qualification of ITI/Act Apprenticeship pass or 10+2 in Science Stream with three years service in skilled grades.
3. Artisan (Helper) level-1 working in Works cadre having experience of three (3) years, provided they fulfill laid down educational qualification and other eligibility criteria for the post.

The selection consists of written test only in terms of Railway Board's letter No.E(NG)I/2000/PM1 /4 dated: 07.08.2003. The candidate should obtain 60% of marks in the written examination. The Panel will be formed based on the aggregate marks in the professional ability and record of service. There will no classification of outstanding as per Railway Board's letter No. E(NG)01/2008/PM7/4/SLP dated: 19.06.2009 (RBE .113/2009).

The employees qualified in the written examination have to pass the medical examination in Aye Three medical classification and their absorption is subject to their successful completion of prescribed training.

A copy of the syllabus for the above selection is enclosed for circulation and there will be questions on official language policy to the extent of 10% of total marks (which is not compulsory).

There will be no supplementary written test.

This notification should be given wide publicity and circulated among all the skilled staff of works branch of Civil Engineering Dept working under your control and this notification should be exhibited in the notice board. The controlling officer should ensure that this notification is circulated/ intimated to the staff who are on deputation / training/ transfer in other unit offices, on leave, sickness etc., Employees on leave/ sick / suspension may also be alerted and acknowledgement obtained.

Last date of submission of application to the supervisory official is **23.06.2023**.

It shall be noted by all the applicants that purely based on the declaration given by them in the application they will be admitted for the written examination. The employees are advised to check up whether they are eligible for the selection particularly with regard to Educational Qualification, requisite years of regular service, community certificate etc., while submitting the application.

The volunteers who fulfill the above mentioned eligibility conditions may submit their application in the prescribed format enclosed. The application submitted by the volunteers should be sent in one bunch duly certified by the concerned supervisory official after verification with the service registers that particulars furnished by the applicants have been verified and the certification made in the application itself. The filled applications should be forward to this office on or before **30.06.2023** certain.

In case no volunteered from your unit for the above selection, a NIL statement may be sent to this office.

1. Specifications and quality control for items of works commonly used in building and Bridge Works, Brick Work, Wood Work, RCC, PSC, Plumbing Work, White Washing / Colour Washing, Painting etc.
2. Schedule of Rates - Scope & Coverage, in general.
3. Inspection and maintenance of buildings, roads, structures, water supply and sanitary arrangements.
4. Leveling and setting out of works.
5. Earth work in Railway projects.
6. Estimating quantities for building works.
7. Passenger Amenities at stations – Categories of stations and minimum essential amenities.
