Sub: Selection for the post of Section Controller in Level 6 in Pay Matrix against 75% PRQ in Operating Department – reg.

It is proposed to conduct selection to the post of Section Controller in Level-6 of VII th PC against 75% Promotional Quota in the Operating Department. The applications are invited in the prescribed proforma from amongst eligible Group C staff of Operating Department of TPJ division.

III) Eligibility Criteria

Age limit and service condition as per PCPO/MAS Letter No.P(S) 535/II/AVC/SC/2017 dated.24.01.2018:

- 1. Upper age limit 52 years as on the date of notification i.e., 01.02.2023.
- 2. Employee should have put in aggregate service of 5 years in the Operating Department as on 01.02.2023 at TPJ Division.

IV) Syllabus

The Syllabus for the written examination is enclosed as Annexure 'A'

V) Pre-Selection Training

The Pre-Promotional training for the eligible "SC" volunteers will be advised separately

VI) Training

The selected employees will be directed to undergo training for Section Controller. On successful completion of training they will be absorbed as Section Controller in pay matrix level-6. The selected employees should not seek reversion to the parent cadre at the time of posting on passing the requisite training. Such of those employees who are not willing to accept these conditions need not apply and those who fail in the training will be directed back to their parent cadre. There will be no supplementary written examination since selection is conducted by calling volunteers.

VII) Criteria for the Selection: -

In terms of Railway Board's letter No. E(NG)1/2000/PM1/41 dated 07.08.2003, the selection for the post of Section Controller in Pay Matrix Level-6 against 75 % PRQ consists of written test only followed by perusal of records of qualified employees.

The written examination will consist of one paper in professional ability as per Syllabus for the written examination, which is enclosed as Annexure "A".

In terms of Railway Board's letter No. E(NG)I/2018/PM1/4 dated 14.12.2018 (RBE No. 196/2018) the question paper will be 100% objective type multiple choice questions for the written examination and 10% of the total marks will be from official language policy and rules. The questions on official language policy and the rules may not, however, be compulsory.

In terms of PCPO/MAS instructions vide PBC No.09/2017 dated 01.02.2017, the question paper will be provided in Bilingual format i.e., Hindi and English.

The examination will be conducted in CBT mode/OMR/Pen and Paper test for a maximum of two hours duration. There will be No negative marking for incorrect Answers as per RBE No.194/2019.

Being a safety category, no relaxation of marks will be allowed in respect of SC/ST employees. The employees who secure 60% in the written examination and 60% in aggregate will be considered for empanelment up to the notified vacancies subject to the suitability being adjudged based on the results of written examination and on scrutiny of record of service. (Seniority cum Suitability).

In case adequate number of employees from the specified categories identified for filling up do not qualify, the shortage will be made good from amongst other specified category employees as per combined Seniority cum Suitability.

If the employees who are already in pay matrix level -6 gets selected they are not eligible for any pay fixation benefit on promotion to the post of Section Controller in pay matrix level-6

VIII) Submission of Applications: -

The supervisory officials will notify the contents of the circular to all staff in regular post under their control and the application in the prescribed proforma as Annexure 'B' from the eligible staff may be forwarded in <u>one bunch in a sealed cover addressed to APO/T/TPJ</u> on or before 22.02,2023

No applications should be sent through the employees in a piecemeal manner. Applications received after the due date will not be entertained.

Supervisors should send a "NIL" report if no application is received from their section. If no "NIL" report is forwarded then it will be deemed that no application is submitted from that section. Any correspondence will not be entertained in this regard. The onus lies with the Supervisory official concerned only.
