
In terms of PCPO/MAS letter cited above, volunteers are called for from among eligible employees in Senior Technicians in Level-6 of VII PC cadre pertaining to Permanent Way / Works unit of engineering department who fulfill the following eligibility criteria.

The list of senior most eligible staff working as Senior Technicians in Level-6 of VII PC and Eligibility and Service conditions of staff: Technician-I in Level-5 cadre pertaining to permanent way/works unit of engineering department who are in the normal zone of consideration. Fitness in AYE-THREE medical classification is mandatory for the

The syllabus prescribed for selection to the post of Junior Engineer / Works against 25% post of JE/Works. Promotional Quota is enclosed in Annexure I for circulation among all the eligible employees. It may be noted that, the number of employees will be restricted to 1:3 from among eligible volunteering employees according to their seniority.

All supervisory officials concerned are advised to obtained application from the eligible Last date of submission of applications: volunteers in the prescribed proforma and forward to Sr.DPO/TPJ in one bunch with a covering letter addressed to APO/E/TPJ on or before 10.04.2023. Applications received after the last date and incomplete applications will be summarily rejected. In case of no volunteers for the above selection, a "NIL" statement may be sent to this office. The selection will consist of written examination and perusal of records. JE/Works being a safety post minimum qualifying marks in the professional ability (ie) written examination will be 60% and the employees must secure 60% marks in aggregate in professional ability as well as record of service for being placed in the panel. There will be no viva-voce. In terms of RBE 17/2014, the empanelment of employees will be on the basis of seniority among those qualifying the professional ability as well as record of service as prescribed in the para above.

The question paper will be in English and Hindi only. The question paper should be 100% objective type with multiple choice questions for the written examination and 10% of the total marks will be from official language policy and rules. The examination will be conducted in OMR answer sheet. There will be no negative marking. There is no relaxation in qualifying marks to employees belonging to
